

1. Preamble

AICTE has announced number of initiatives under its Quality Improvement Scheme for the year 2016-17. Share and Mentor Institutions (Margdarshan) is one of such schemes. The scheme envisages that a Hub 'n Spoke system is to be established by an Institute of repute as a Mentor within an existing facility to serve as the hub to guide and disperse knowledge to ten technical institutions to encourage best practices. The secondary branches, the spokes, are additional services provided to faculty for self-improvement. Eventually, the Hub 'n Spoke system will allow for inter hamlet information sharing, such as helping mentee Institutes to improve their quality parameters and enable them to get accreditation by NBA. SVEC, a premium Institute in the State of Andhra Pradesh has been selected by the AICTE to serve as a Mentor Institute in the region.

2. Objectives of the MOU

The aim of this MoU is to stimulate and facilitate the development of collaborative and mutually beneficial programs which serve for technical upliftment of both campuses.

The objectives of the MoU are:


- To promote and enhance academic interaction between SVCE & SVCN.
- To share and implement best practices for enhancing quality of teaching learning processes.
- To conduct faculty development programs for the benefit of teachers of member and other Institutes.
- To conduct training programs for the benefit of non-teaching staff of member and other Institutes.
- To provide help in developing NBA process and accreditation.


3. Duration

This MoU shall remain effective from the date of execution until the end of the term of three (3) years. However, same also may be amended, terminated or extended by agreement.

4. Terms and Conditions

- Cost of development of any infrastructure at SVCE shall be borne by SVCE through the funds available under the scheme from AICTE and its own funds.
- The activities under this program shall be conducted either at SVCE or at SVCN.
- The host Institute will bear all expenses towards hospitality and conduct of activity. Travel expenditure for the participating member shall be borne by the parent organization (SVCN).
- Each Institute agrees to depute at least one and maximum two members for each of the faculty development / training programs planned by SVCE, except when the program has no relevance to Institute concerned.
- The mentee institute will submit details of quality improvement, outcome attainments, Self-Assessment Report, evaluation report and accreditation certificates of programs by NBA to the mentor institute, so that this scheme coordinator can submit the same to AICTE


- Any dispute pertaining to this MoU shall be referred to Principal, SVCE and his / her decision will be binding on both the Institutes.
