- 1. The "Sree Venkateswara College of Engineering, Golden Nagar, NH-5, North Rajupalem Bypass Road, Kodavalur, Nellore" was given Temporary affiliation for running Degree courses during the academic year 2018-19 vide Procs.(1) read above.
- 2. The AICTE, New Delhi and Government of A.P have accorded extension of approval to the above college for the academic year 2019-20 vide ref (2) and (3) read above. The University has constituted a Fact Finding Committee to verify the staff and infrastructure facilities of the college to consider for grant of Temporary affiliation for the academic year 2019-20 vide Procs. (4) read above. The Fact Finding Committee has visited the college and submitted its report to the University vide (5) read above. The University has constituted a Standing Committee for Affiliation to verify the reports which were submitted by the Fact Finding Committee. The Standing Committee for Affiliation of the University has verified the reports which were submitted by the Fact Finding Committee and made recommendations for granting Temporary Affiliation for the academic year 2019-20 vide (ref.6) read above.

The Standing Committee for Affiliation has identified the following deficiencies and recommended to rectify the same and submit a compliance report, within 02 months.

- 1. Built up area should be made available as per AICTE norms
- 2. At least 50 % of the faculty appointments have to be ratified by the University
- 3. Faculty cadre ratio is to be maintained as per AICTE norms
- 4. The college should apply for NBA, NAAC status
- 5. Licensed software should be procured
- 6. Journals should be subscribed in the library
- 7. Digital library should be established
- 8. Lab technicians should be appointed with technical qualification
